## TRANSFER OF QUARRY LEASE FORM

### Instructions

- Section 8(5)(b) of the **Quarry Materials Act (QMA)** provides for the transfer of a lease.
- A transferred lease will allow for the continued operation of a lease under the same terms, conditions and approved development, rehabilitation, and closure requirements as the original lease.
- Amendment of the development, rehabilitation and closure plan or conditions of the lease is a separate process.
- The Transferor and Transferee must complete this "Transfer of a Quarry Lease Form".
- The Transferor is the existing lessee. The Transferee is the proposed future lessee.
- If the Transferee is a company, the company must be registered and in good standing with the Registry of Companies and Deeds.
- Proof of ownership of the land, including but not limited to a deed or title is required for a lease that encompasses any part of private property; **Or**
- If the land is owned by someone other than Transferee, the property owner's written permission to quarry and occupy the property must be included with this form.
- The form must be signed, sealed and dated by a Notary Public, Commissioner for Oaths or similar. Forms submitted without this information will not be accepted.
- If the transfer is approved, the Transferee must post financial assurance in the amount specified in an approved development, rehabilitation, and closure plan in accordance with Section 10 of the **Mining Act**.
