



Form for Preparation of a Work Plan for Mineral Exploration in Labrador Inuit Lands

Any person who wishes to carry out an Exploration Program in Labrador Inuit Lands must submit a Work Plan to the Government of Newfoundland and Labrador and the Nunatsiavut Government detailing the proposed Exploration Program for approval.

The Work Plan must be submitted by e-mail to:

The text of the Work Plan must be attached and submitted as a Word file.

Maps and Plans included with the Work Plan must be attached and submitted as ArcView Shape Files (.shp, .dbf, .prj and .shx) and Adobe Acrobat Portable Document Format (pdf) file.

Applicants are encouraged to submit applications as early in the calendar year as practicable in all cases at least 30 days before the planned start of the work. Applicants are also encouraged to communicate with Nunatsiavut Government officials for purposes of seeking their informal views with respect to proposed Work Plans before finalizing them and formally submitting them for approval.

Any informal view expressed by Nunatsiavut Government officials is of no force or effect and is not intended to predetermine the outcome of Nunatsiavut Government's consideration of whether the Work Plan is consistent with, or conforms to, the Standards.

The Work Plan must be certified to be true, accurate and complete by the Applicant or, if the Applicant is not a natural person, the exploration manager of the Applicant.

- 11. Describe measures to be used at the site to delineate and mark the Site on the ground, identify the Plan Holder and protect the safety of individuals entering the Site:

- 13. State how exploration on Labrador Inuit Lands will maximize employment opportunities for Labrador Inuit and the purchase of goods and services from Labrador Inuit businesses:
- 14. Identify any endangered of threatened species in the vicinity of the site and any known sensitive areas or sensitive time periods for fish, wildlife of their habitat:
- 15. Identify the location of trap lines, camps, cabins or other evidence of recent use and occupancy that exists in any area in which exploration activity may be carried out:
