**PRIVACY STATEMENT** Under the authority of the *Highway Traffic Act* (HTA), personal information will be collected for the purpose of issuing a Newfoundland and Labrador vehicle registration. Section 6 of the HTA allows Motor Registration Division to disclose an applicant's personal information to law enforcement, the government of another Canadian jurisdiction, select federal, provincial and municipal officials. ## **Notes on Affidavit Sale/Acquisition of a Motor Vehicle**

This affidavit is to be completed, for Retail Sales Tax purposes, by both the seller of a motor vehicle in Newfoundland and Labrador and a person acquiring or bringing a motor vehicle into Newfoundland and Labrador, when:

- the purchase price or value upon acquisition of the vehicle is less than the average wholesale value as published in the Canadian Red Book or other publication approved by the Minister of Finance for this purpose; and
- the vehicle is acquired from a person who is not a “registrant” for GST/HST purposes.

The affidavit is to be provided to Motor Registration Division, Digital Government and Service NL. An affidavit is not acceptable when there have been changes made to it.

The affidavit may be completed separately by purchaser and seller on individual forms, but must be submitted to Motor Registration together.
