

Register a Homemade/Recreational **Use Trailer**

Motor Registration Division

Motor Registration Division Fees Policy defines a recreational trailer and the prescribed trailer registration fees as follows:

- A personal use recreational trailer must be registered annually.
- "Recreational trailer" means a cabin trailer, collapsible cabin trailer, tent trailer, camping trailer; a trailer used to transport recreational equipment such as a snowmobile, watercraft, fishing and hunting equipment, off-road motorcycle or a bicycle where that transport is not in connection with a business, employment or commercial enterprise.

A recreational trailer must:

- be registered in an individual's personal name
- be used strictly as a personal recreational trailer
- not be operated for business or commercial use.
