Re: 2025-2026 Call for Applications Deadline Reminder

Date: November 25, 2024

The Department of Transportation and Infrastructure would like to remind eligible funding recipients that Municipal Capital Works (MCW) applications for its 2025-2026 cost shared funding program are due on **Friday, November 29, 2024**. The application period was opened on October 30, 2024, via circular (see <https://www.gov.nl.ca/ti/mi/circulars/>).

The Application Guide outlines submission requirements and program information for this Call for Applications. Applicants are encouraged to read the Guide to ensure they submit all required information by the deadline. Application Guide is available on MI's website at: <https://www.gov.nl.ca/ti/mi/apply-for-funding/>. Note that MI may reject any late or incomplete applications received.

Applicants are reminded about the following considerations announced in the circular:

1. Applications that suitably address existing Boil Water Advisories, compliance with Federal Wastewater Systems Effluent Regulations, or the impacts of climate change are of particular interest to MI.
2. TI is working with Canada to finalize the Canadian Housing Infrastructure Fund (CHIF) program. TI anticipates using applications submitted during this Call for Applications for the first round of CHIF funding, should suitable applications be received. TI will reach out to applicants over the winter to fill any information gaps.
3. A reminder that Multi-Year Capital Works (MYCW) funding recipients are ineligible for MCW funding. That said, MYCW recipients who have applications potentially eligible for CHIF may submit during this Open Call.
