Re: Federal Budget 2022 ICIP Commitment

Date: May 30, 2022

Deadline: June 10, 2022

Applications submitted during the 2021 open call continue to be under active consideration for funding under the Investing in Canada Infrastructure Program (ICIP).

Federal Budget 2022, announced on April 7, 2022, includes the following passage:

“Budget 2022 signals the [federal] government’s intention to **accelerate the deadline for provinces to fully commit their remaining funding under the Investing in Canada Infrastructure Program to priority projects to March 31, 2023 [instead of March 31, 2025]**. As a measure of fiscal prudence, any uncommitted funds after this date will be reallocated to other priorities. The federal government will work closely with provinces to support them in expediting project submissions...”

To assist in meeting this deadline and ensure that ICIP funds are allocated to projects, Municipal Infrastructure is inviting communities to provide information on any project(s) within a short-term planning horizon that have not already been submitted for consideration during the 2021 open call for applications.

If your community wishes to provide information on any additional project(s) for consideration (or indicate any re-prioritization of already submitted applications), we ask that you please email MunicipalInfrastructure@gov.nl.ca by **June 10, 2022** addressing:

1. Any change in priority of applications already submitted in 2021 if applicable.
2. Any additional priorities in planning stages and not yet submitted to Municipal Infrastructure during the 2021 open call for applications. Any additional priorities submitted should include:
 - a. Project title
 - b. Tentative scope
 - c. Total project cost

Should you identify any additional projects for consideration, we will contact you to make full application in MSIS at a later date.
