Re: Call for 2023-2024 Municipal Infrastructure Applications

Date: September 28, 2022

The Municipal Infrastructure Division (MI) of the Department of Transportation and Infrastructure is inviting eligible funding recipients to submit applications for its 2023-2024 Municipal Infrastructure Cost-Shared Funding Programs. The Application Guide which outlines available cost sharing programs and application requirements can be found on our website at:

The deadline to submit applications is October 28, 2022. The Government of Canada will no longer be accepting Investing in Canada Infrastructure Program (ICIP) applications after March 31, 2023. For this reason, **this call will be MI's last intake period specifically for ICIP.**

Given the compressed timeframe for submission of applications, MI has made some changes to the application process and content. This year the Call for Applications will proceed in three phases:

Phase 1 – Application Intake

- This phase will see Applicants make brief submissions with enough information for MI to understand the nature of the project and anticipated costs.

Phase 2 – Application Review and Selection

- This phase will see MI review submissions, make notional selections, and notify those Applicants.

Phase 3 – Submission of Additional Information

- Those Applicants notified will have a brief timeframe for submission of additional information as requested by MI.
- MI will review submissions, and provide to Infrastructure Canada if deemed complete.

While there is no restriction on the type of application that can be submitted during this call, **MI is particularly interested in receiving applications that suitably address existing Boil Water Advisories or compliance with federal Wastewater Systems Effluent Regulations.**
